[Montenegro:]

- According to the last population census from 2011, in Montenegro was 625,266 inhabitants
- The capital city is Podgorica - 187,085 residents or 30% population
- Montenegro have area of 13 812 km² which is divided into 23 municipalities

[primary health care:]

- Consists of 18 Primary Health Care Centers
- Primary Health Care Center is referential primary health care centre providing support to the chosen team of doctors (health care system reform from 2004.),
- On primary health care level is solved the majority of health issues,
- Most of the health data in our system is generated on primary health care level

[primary health care - IT:]

- On primary health care level is implemented integral IS of Health Care Centers (together with stomatology and pharmacy).
- Since 2009, electronic receipt, electronic referral, electronic notes of remittance for sick-leave and entire electronic billing system has been set in place in the Montenegrin health care system, at the primary health care level.
- *All operating processes in delivering of medical services in health care system in Primary Health Care Centers are **IT** supported*

[secondary and tertiary health care:]

- Secondary level consists of seven General Hospitals and three Specialized Hospitals
- Tertiary level consists of Clinical Centre of Montenegro (which is on secondary level as well for Podgorica), and Public Health Institute of Montenegro
- Next step: organized health care system in Montenegro inside the 8 regional centers which all of them will consist of components of all three levels of health care.

secondary and tertiary health care - IT:

- On secondary health care level is implemented IS of General hospitals
- For Clinical Centre of Montenegro (partly on tertiary health care level) integral IS for the hospital is not implemented yet, that is the next step
- Institute for Public Health – implemented IS
- Agency for Medicines and Medical Devices of Montenegro, CALMIS – implementet IS
- Health insurance Fond- Implemented IS

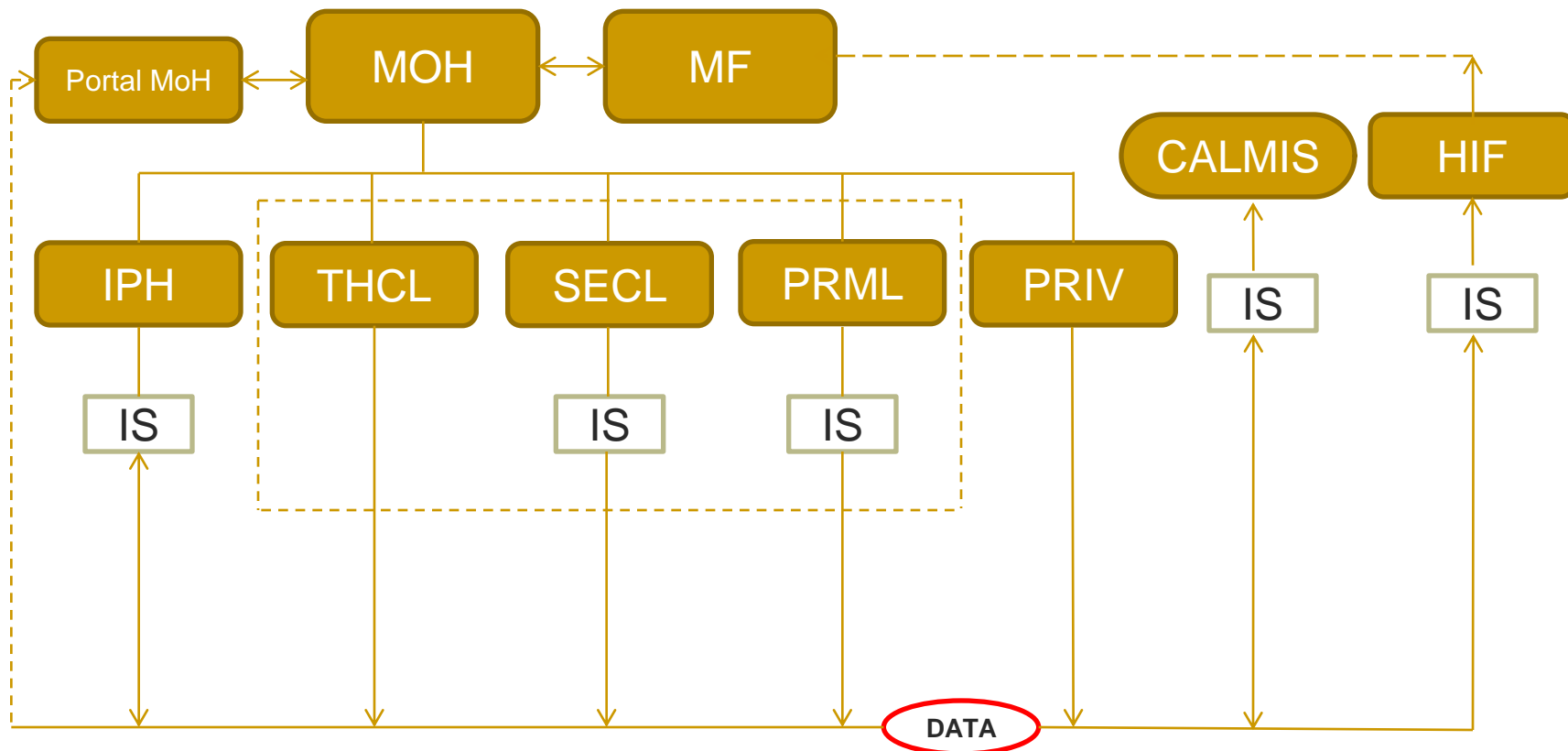
[private and public health care institutions]

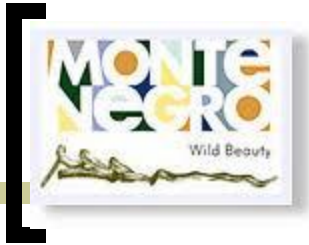
- Private health care institutions don't have integrated system and they are not connected in the network
- Ministry of Health work on the last part of the project WebPortal of Ministry of Health, which consist register all the private and public health institutions in the Montenegro.
- On public part of the MoH portal, it will be available to the citizens general information about all private and public health care institution (address, telephone number, specialization).

[Portal MoH]

- Resource web portal of the Ministry of Health of Montenegro enables centralized collection, maintenance and reporting on the most vital resources and statistical data related to the health care system.
- Resource Portal allows centralized maintenance of common code lists, classification and nomenclature (such as ICD, ATC code lists, code lists of services, etc.) used in the health system (catalogs), which are the competence of different institutions (Health Insurance Fund, Institute of Public Health etc.), collection and maintenance of resource registers related to basic health facilities of the health system, such as:
 - The organizational structure of the health system to the level of organizational units within health facilities,
 - Register of all employees in the health system,
 - Register of medical equipment.
 - Presenting the most important medical and statistical information collected across the health system.
